E-LEARNING AND CRICOS STUDY TRANSITION ARRANGEMENTS – FAQ’S

- ❖ Students **who are not resident** in Australia and are out of Australia at the time of enrolment will be able to study online. Qualifications available to study online are at the Certificate III & Certificate IV level in the Table above. The special online tuition fees are applicable to your enrolment. Completion of Online Study Modules in each qualification will result in you obtaining a Certificate of Completion for each unit
- ❖ **Do I have to pay extra fees for work practical assessment?**
YES. \$1,500.00. The Special Tuition fees in the table above are ONLY FOR ONLINE theory modules. The fees **DO NOT** include **the** Practical Placement and Assessment required to obtain a full Australian accredited Qualification. Students who want to receive our full Australian Accredited Qualification must notify our admissions officer your interest to complete practical placement assessment.
- ❖ **What is involved in Practical Assessment?**
 This means that an Australian accredited & qualified trainer and assessor who holds industry currency needs to assess you as competent. Assessments may only be conducted in Australia OR at one of our Approved practical placement facilities. Admissions can provide you with further information on request.
- ❖ **What if I find my own Practical Placement, will I still need to pay the additional Practical Placement Assessment Cost?**
 If you find your own work placement facility in Australia, your assessor will arrange to conduct your practical assessment with the approved facility. You will only be required to pay Work Placement fee of 50% of the Standard Practical Placement Cost
- ❖ **Location of Practical Placement Assessment?**

OPTION 1 – TRAVEL TO AUSTRALIA FOR SHORT TERM STUDY HOLIDAY

- ❖ You may choose to have a combined Study Holiday Tour for a short period. You must apply for a visitor visa which is valid up to 3 months. The visitor visa will usually allow you to undertake up to 3 months study for short periods without having to apply for any study visas. You will need to ensure you satisfy the criteria for a visitor’s visa when you apply for it. Educare admissions student services will assist in coordinating your arrival and work placement with one of our approved Australian provider facilities

OPTION 2 - WHAT ABOUT COVID19 INTERNATIONAL TRAVEL RESTRICTIONS?

- ❖ With restrictions still in place, you can complete all your online modules and receive a Certificate of Completion for theory units completed. A full qualification will be issued after the 120 hours vocational placement has been achieved in Australia. Should you still want to travel to Australia to complete your practical assessment and remain to further study one of our packages, you must notify your admissions officer of your intention. You will be advised to apply for the correct Student Visa SC500 for International Cricos Students. This means you must request or complete our **International Cricos Student Enrolment form** for the additional Package Qualifications. This enrolment process will contain instructions related to International Cricos Study regulations.
- ❖ **What happens after I complete my online modules, travel to Australia, complete my practical placement during the short-term Study Holiday Tour period and decide I want to continue my studies with Educare College?**
 We would be happy to have you continue your studies with us. You will need to speak with our International Enrolment team who will advise you suitable course pathways.
